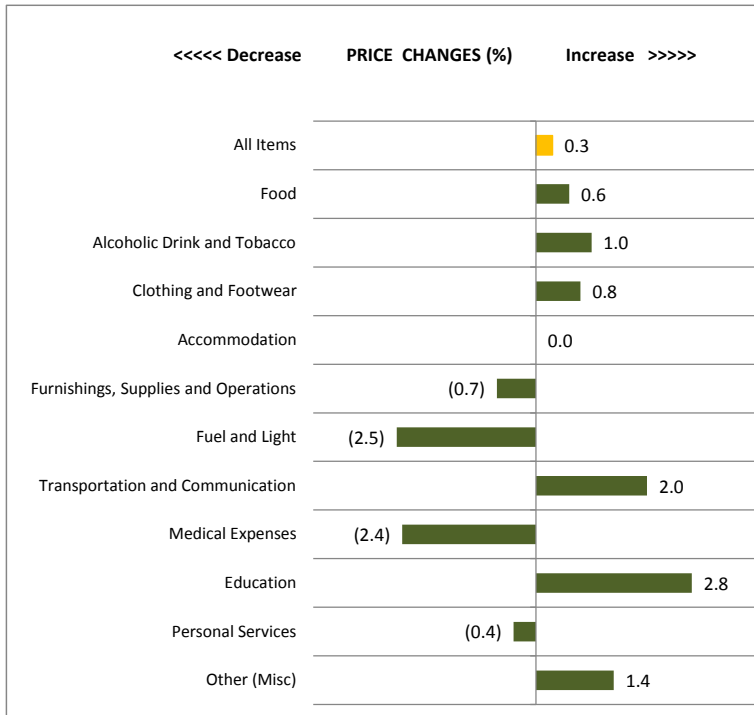

## Headline Inflation: Year-on-Year Changes for Feb 2014 compared to Feb 2013



In February 2014, the annual rate of inflation was measured at 0.3%, 0.2 percentage points lower than the January inflation rate of 0.5%. Food prices increased by 0.6% over the twelve month period from February 2013, a reduction 0.8 percentage point compared to the previous month of 1.4%. In Fruits and Vegetables, a sub category of Food, the average price increased by 3.6%, Food N.E.S. (not else specified) by 3.1% and Dairy Products 1.3%.

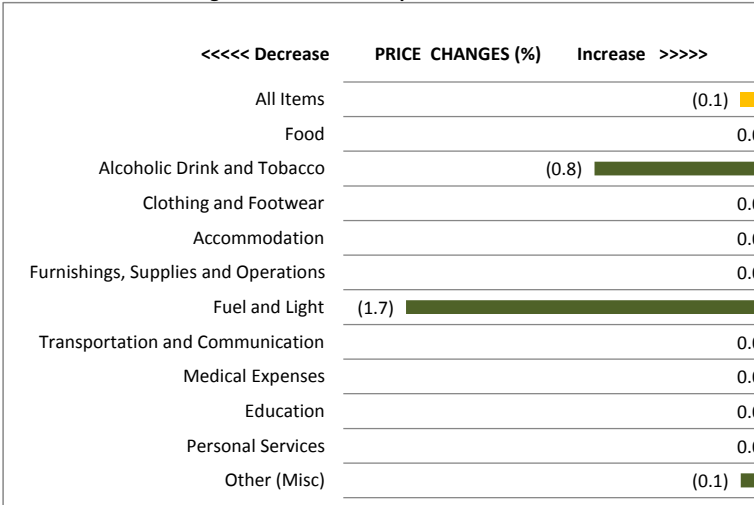
In the Fruits and Vegetables sub category, the price changes for broccoli, irish potatoes and canned vegetables contributed to the increase in the index. Broccoli increased from \$5.95 to \$8.44 per pound, irish potato increased from \$2.34 to \$2.64 per pound and a can of mixed vegetables increased from \$3.39 to \$3.58.

The Food N.E.S. sub category increased by 3.1%. This was primarily caused by average price increases in the Meals Out and Miscellaneous Food sub categories. Meals out increased by 4.3%, fried chicken with fries was the major contributing factor to this increase as was the case in the January index. Miscellaneous Food increased by 4.8% which was influenced by the average price increase of soups and potato chips.

A 1.3% increase was recorded for Dairy Products. Increases in the average price of evaporated and powered milk led to a 1.0% increase in the Milk sub category.

The Fuel and Light index decreased by 2.5% over the same period due to a decrease in the fuel variation rate from 80 cents in February 2013 to 77 cents in February 2014.

## Month-to-Month Changes for Feb 2014 compared to Jan 2014



There was a 0.1% reduction in the All Item index between February and January 2014. The Food index recorded no change during the same period.

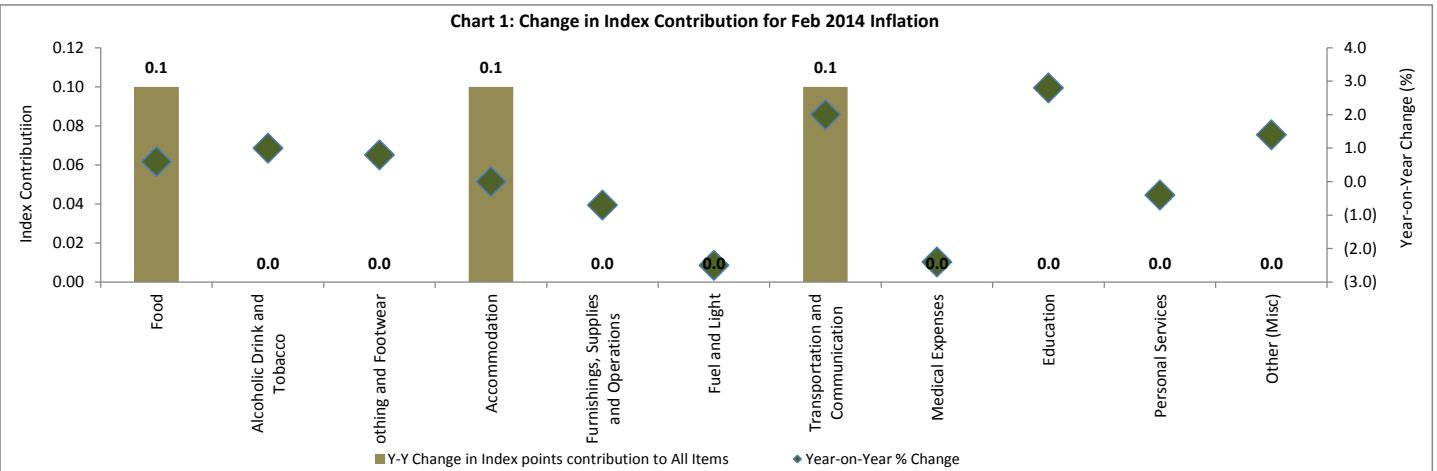
Decreases were recorded for Fruits and Vegetables of 1.1% and Meats 0.7%. Fruits and Vegetables decrease was attributed to a 4.9% decrease in the Vegetables sub category. Decreases in average prices were recorded for onions, cabbage and tomatoes. The average price per pound of onions declined from \$3.16 to \$2.87, cabbage \$3.40 to \$3.24 and tomatoes from \$5.45 to \$4.54.

Alcoholic Drink and Tobacco decreased by 0.8% over the same period. Decreases in prices for Imported vodka and cigarettes contributed to the decline.

The Fuel and Light index decreased by 1.7%. The fuel variation rate decreased from 79 cents in January 2014 to 77 in February 2014.

Other (Miscellaneous) decreased by 0.1%. The decrease was influenced by a decrease in the average price of toothpaste and toothbrush.

### What is the Consumer Price Index?

The Consumer Price Index (CPI) is a statistical indicator of changes in the general level of prices of consumer goods and services purchased by private households. The CPI measures price movements of a fixed quality and quantity of goods and services. The mix of these consumer goods and services comprising the CPI are referred to as a "shopping basket." In constructing this "shopping basket", the selected goods and services are organised first by commodity type. They are then divided into sections, then sub-groups and then assigned to a major expenditure category. The Antigua and Barbuda CPI has 26 sections, 30 sub-groups and 11 major categories.

### What is the Base Period?

The base period (base year) is the time period that is used as a reference point for measuring the price change of goods and services. The base period for the Antigua and Barbuda CPI is January 2001.

The base period index is represented as 100.0. (Usually presented as 2001 = 100). So for instance, if the April 2010 CPI for chicken legs is 167.1, then it means that the price for chicken legs has gone up by 67.1% since 2001. Similarly, if the January 2010 CPI for bread is 93.1, then the price of bread has dropped by 6.9% compared to its price in 2001.

### What is Inflation?

Inflation is the process of rising prices, resulting in diminishing purchasing power of a given amount of money. There are three expressions of price changes:

- year-on-year (*the inflation rate*)
- month-to-month
- annual average (or annualised average)

The annual average CPI is derived by summing the CPI for each month of the year and dividing by 12.

### What are Weights?

Weights can be considered in the same way we would express how much we spend on various goods and services each month. Just like a monthly salary can be broken down as 20% on rent, 25% food, 15% mortgage, 10% on utilities and so on, the CPI weights are a collective expression of how households would generally spend their monthly income on goods and services.

The weights for this series of CPI were drawn from a survey of a sample of households in 2001 (the base period). Each household was asked to keep a record of their expenditure for one month. Once completed, the expenditures were added to determine the pattern. This pattern is what is referred to as the weights.

The current weights assume that each month, households would spend the most on *Accommodation* (218.3) followed by *Food* (214.2) and *Transportation and Communication* (153.5). Households would also spend the least on *Alcoholic Drink and Tobacco* (1.6).

### Index Points Contribution

Contribution of each expenditure category (category weight over All Items weight) to the All Items index points change.

The Statistics Division wishes to acknowledge the cooperation of the business community in supplying the required prices and accommodating the Statistical Officers on their premises. Price collection is authorised by the *General Statistics Act, No. 13 of 1975*.

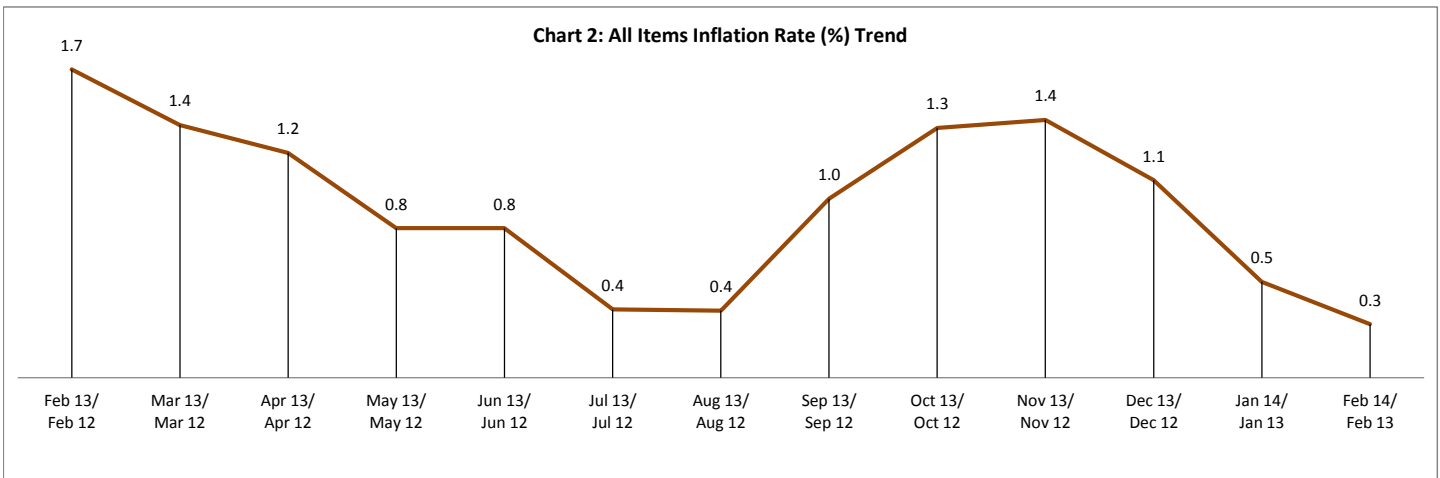

In Feb 2014 compared to Feb 2013, 4 of the 11 main expenditure categories recorded price decreases, while 6 recorded price increases. 14 of the 26 sub-group levels also recorded price increases for some of the items that fall in that level. These collective increases and decreases would account for the magnitude and direction of the current inflation rate. 1 of the 11 main expenditure categories recorded no price changes.
