



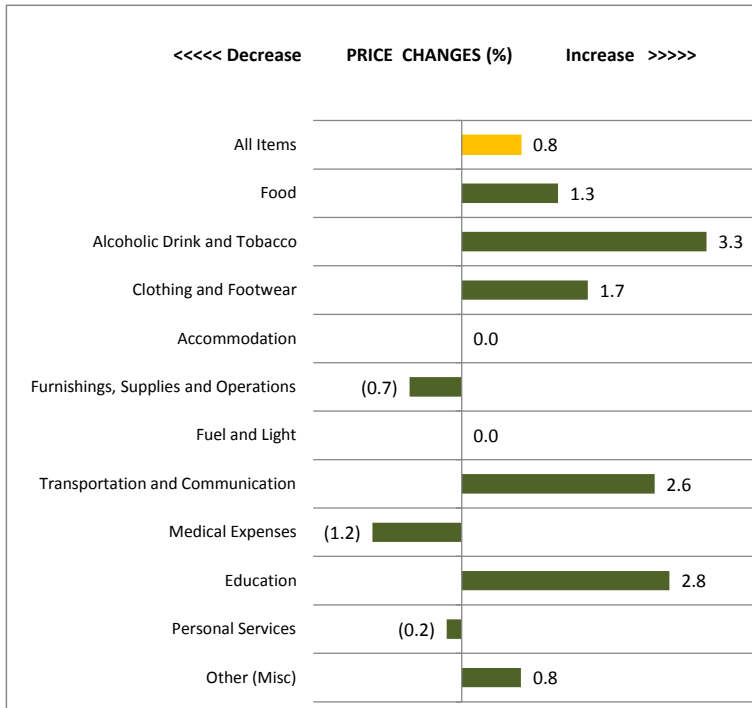

Jun 2014 Inflation Rate 0.8%

Headline Inflation: Year-on-Year Changes for Jun 2014 compared to Jun 2013



In June 2014, the Consumer Price Index increased by 0.8%. Food prices rose by 1.3% over the twelve month period from June 2013 to June 2014 with the index for Fruits and Vegetables up 5.4% over the period. Price changes in canned vegetables and lettuce contributed to this increase. The average price of canned mix vegetables increased from \$3.46 to \$3.91 and lettuce increased from \$4.83 to \$5.45.

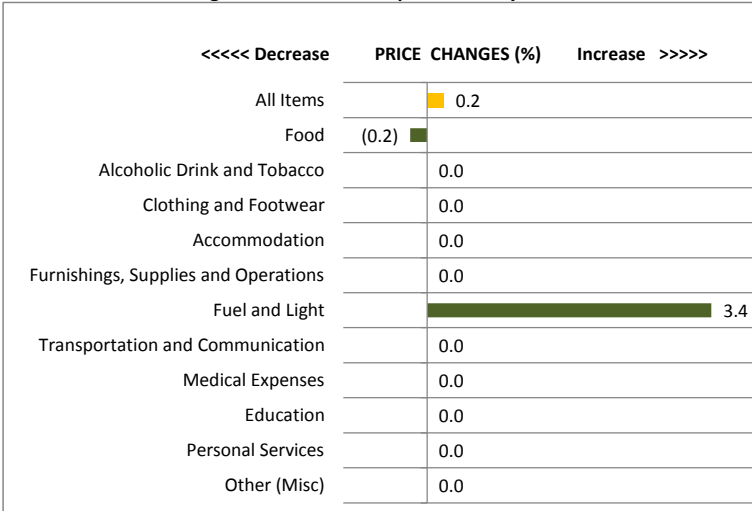
Food N.E.S. (not else specified) index increased by 3.3% with the sub-group Condiments and Spices increasing by 1.6%. The average price of ketchup increased from \$7.82 to \$8.35. The index for Meat increased by 0.9%. Poultry and fish continue to influence the low Meat index. The Poultry index declined by 2.0%, this was influenced by the decrease in the average price of chicken wings, legs and whole chicken per pound.

The Fuel and Light index had no change over the period. The fuel variation rate remained at 81 cents for both periods.

Alcoholic Drink and Tobacco increased by 3.3% over the same period. Guinness stout increased from \$4.48 to \$4.86, imported vodka increased from \$35.61 to \$37.52 and cigarettes increased from \$6.49 to \$6.65.

The All Items less Food and Energy index remained at 0.8% over the last three months. The index for airline fares declined by 9.0%. Airline fares to Puerto Rico declined from \$1196.04 to \$1077.73. The Medical Care index decreased by 1.2%, the Drugs and Medical Supplies index declined by 7.0%. The Clothing and Footwear and Furnishings, Supplies and Operations indexes remain unchanged from April 2014.

Month-to-Month Changes for Jun 2014 compared to May 2014



There was 0.2% increase in the All Item index between May and June 2014. The index for the Food category declined by 0.2% between this period. Bakery and Cereals Products index increased by 0.4%, this was influenced by increases in the average price of cream of wheat and pasta products.

In the Dairy Products, the index declined by 1.1% due to average price reduction for eggs and powdered milk. A dozen eggs reduced from \$10.37 to \$9.81 and a 900 gram of powdered milk reduced from \$34.28 to \$33.65.

A decline was also recorded for the Fats and Oil Index. The index declined by 0.5% due to an average price reduction for fresh butter and lard.

The index for Sugar, Jams and Confectionery declined by 2.1%, the second decrease in two months. The decrease was affected by average price decrease for a pound of white sugar and pan cake syrup.

The Fuel and Light index increased by 3.4%. The fuel variation rate increased from 78 cents in May 2014 to 81 cents in June 2014.

Chart 1: Change in Index Contribution for Jun 2014 Inflation

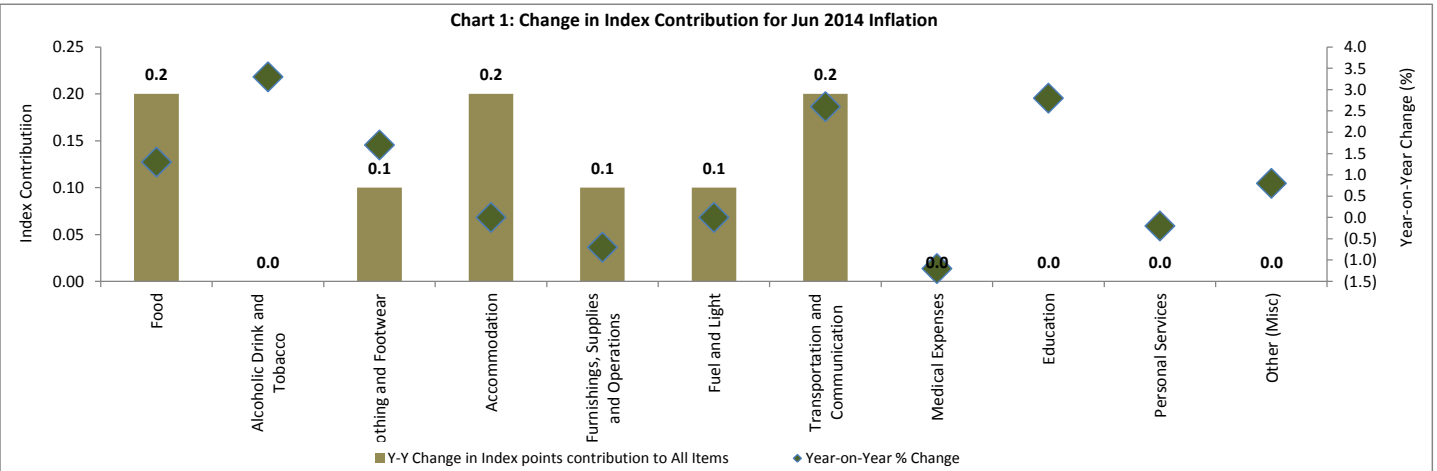

What is the Consumer Price Index?

The Consumer Price Index (CPI) is a statistical indicator of changes in the general level of prices of consumer goods and services purchased by private households. The CPI measures price movements of a fixed quality and quantity of goods and services. The mix of these consumer goods and services comprising the CPI are referred to as a "shopping basket." In constructing this "shopping basket", the selected goods and services are organised first by commodity type. They are then divided into sections, then sub-groups and then assigned to a major expenditure category. The Antigua and Barbuda CPI has 26 sections, 30 sub-groups and 11 major categories.

What is the Base Period?

The base period (base year) is the time period that is used as a reference point for measuring the price change of goods and services. The base period for the Antigua and Barbuda CPI is January 2001.

The base period index is represented as 100.0. (Usually presented as 2001 = 100). So for instance, if the April 2010 CPI for chicken legs is 167.1, then it means that the price for chicken legs has gone up by 67.1% since 2001. Similarly, if the January 2010 CPI for bread is 93.1, then the price of bread has dropped by 6.9% compared to its price in 2001.

What is Inflation?

Inflation is the process of rising prices, resulting in diminishing purchasing power of a given amount of money. There are three expressions of price changes:

- year-on-year (*the inflation rate*)
- month-to-month
- annual average (or annualised average)

The annual average CPI is derived by summing the CPI for each month of the year and dividing by 12.

What are Weights?

Weights can be considered in the same way we would express how much we spend on various goods and services each month. Just like a monthly salary can be broken down as 20% on rent, 25% food, 15% mortgage, 10% on utilities and so on, the CPI weights are a collective expression of how households would generally spend their monthly income on goods and services.

The weights for this series of CPI were drawn from a survey of a sample of households in 2001 (the base period). Each household was asked to keep a record of their expenditure for one month. Once completed, the expenditures were added to determine the pattern. This pattern is what is referred to as the weights.

The current weights assume that each month, households would spend the most on *Accommodation* (218.3) followed by *Food* (214.2) and *Transportation and Communication* (153.5). Households would also spend the least on *Alcoholic Drink and Tobacco* (1.6).

Index Points Contribution

Contribution of each expenditure category (category weight over All Items weight) to the All Items index points change.

The compilation of the CPI and the calculation of the inflation rate involve the processing of hundreds of price quotations. The Statistics Division wishes to acknowledge the cooperation of the business community in supplying the required prices and accommodating the Statistical Officers on their premises. Price collection is authorised by the *General Statistics Act, No. 13 of 1975*.

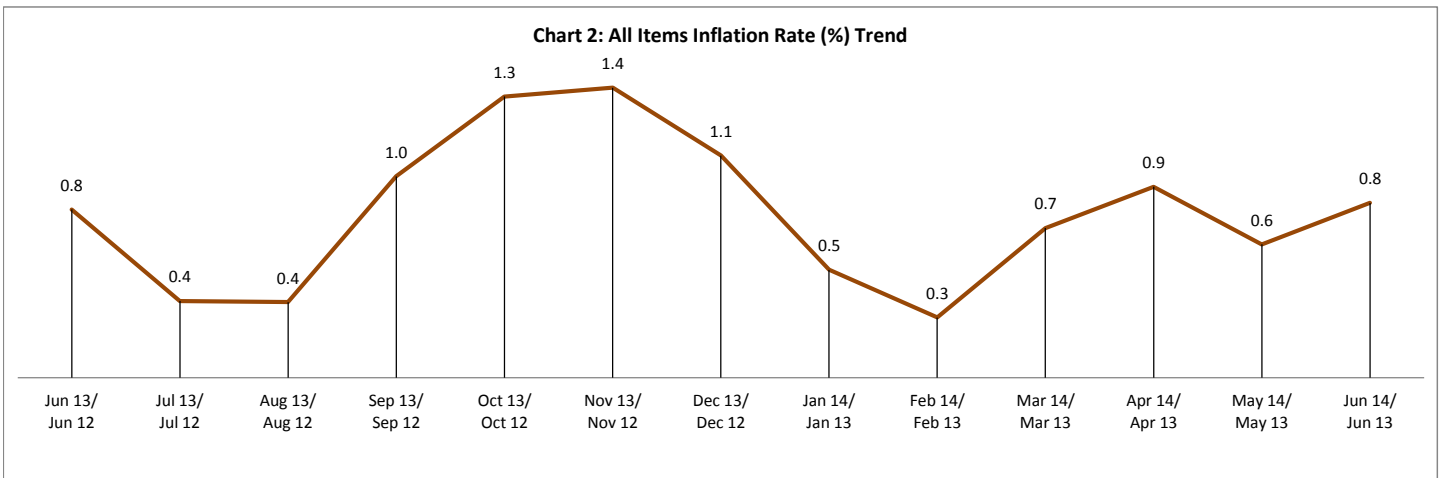

Table 3 outlines the distribution of price movements for four inflation periods:

Jun 2014 compared to Jun 2013
 May 2014 compared to May 2013
 Apr 2014 compared to Apr 2013
 Jun 2014 compared to May 2014

In Jun 2014 compared to Jun 2013, 3 of the 11 main expenditure categories recorded price decreases, while 6 recorded price increases. 16 of the 26 sub-group levels also recorded price increases for some of the items that fall in that level. These collective increases and decreases would account for the magnitude and direction of the current inflation rate. 2 of the 11 main expenditure categories recorded no price changes.
