



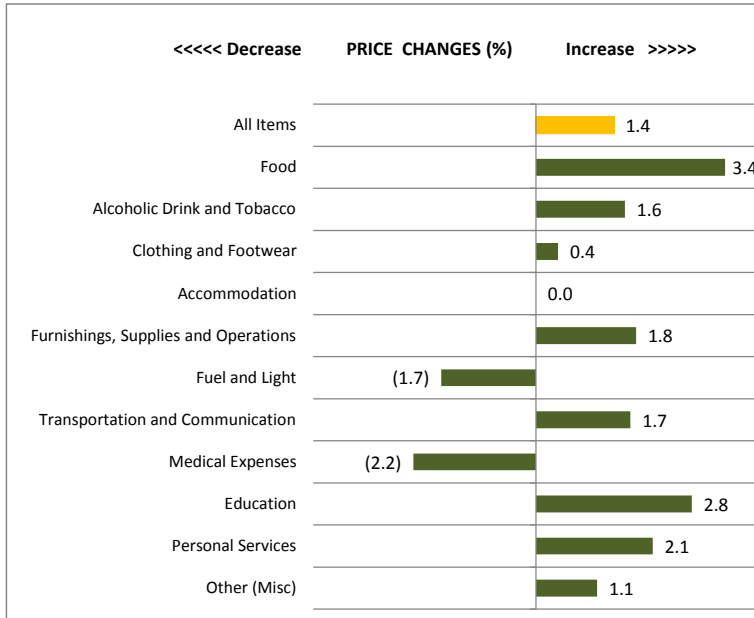

Headline Inflation: Year-on-Year Changes for Nov 2013 compared to Nov 2012



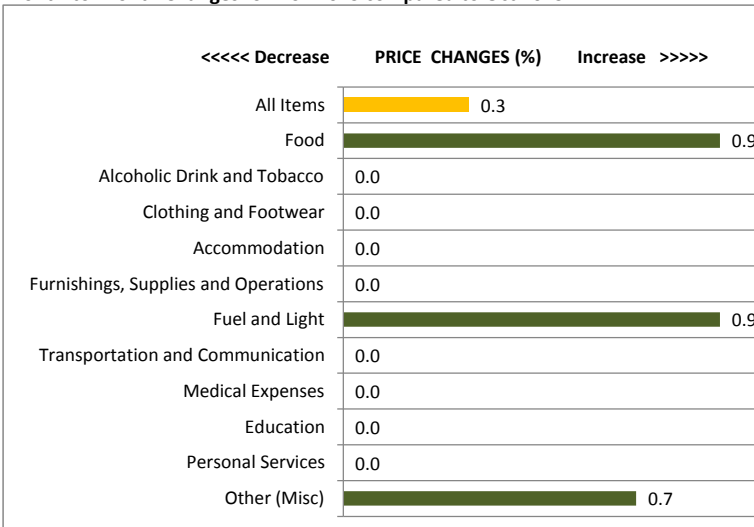
In November 2013, the annual rate of inflation was measured at 1.4%.

Price changes in the Food category show a 3.4% increase compared to November 2012. Dairy Products recorded an increase of 3.3%. This was related to an average price increase in evaporated milk, eggs and powdered milk. Evaporated milk increased from \$3.66 to \$3.84, eggs per dozen increased from \$9.48 to \$9.93 and powdered milk 900g from \$30.22 to \$31.77.

Fats and Oils increased by 3.3%. Increases were recorded for salad dressing, olive oil and peanut butter. Price increases were also recorded both for table and cooking margarine. Table margarine increased from \$11.49 to \$11.56 and cooking margarine increased from \$7.14 to \$7.39.

The Fuel and Light index decreased by 1.7% over the same period due to a decrease in the fuel variation rate from 80 cents in November 2012 to 78 cents November 2013. When energy is removed from the All Items index, the inflation rate is 1.7%, demonstrating the impact of energy prices on inflation. Energy, a special index that measures price changes for electricity (fuel variation rate), gasoline at the pump and LPG.

Month-to-Month Changes for Nov 2013 compared to Oct 2013



There was a 0.3% increase in the All Item index between October and November 2013. The Food index increased by 0.9% during the same period, this was related to increases in the average prices of Fruits and Vegetables and Food N.E.S (not elsewhere specified).

Fruits and Vegetables category recorded an increase of 10.3%. Vegetables the sub-category recorded an increase of 23.6%. This was attributed to average price increases in carrots, cucumbers and tomatoes. The average price of a pound of carrots increased from \$3.35 to \$3.79, cucumbers increased from \$3.89 to \$4.34 and tomatoes increased from \$5.92 to \$6.22.

Food N.E.S (not elsewhere specified) increased by 2.1%. This was due to increases in condiments and spices. The average price of a 35fl oz ketchup increased from \$8.55 to \$8.89.

The Fuel and Light index had an increase of 0.9%. The fuel variation rate increased from 77 cents in October 2013 to 78 cents over the same period.

Chart 1: Change in Index Contribution for Nov 2013 Inflation

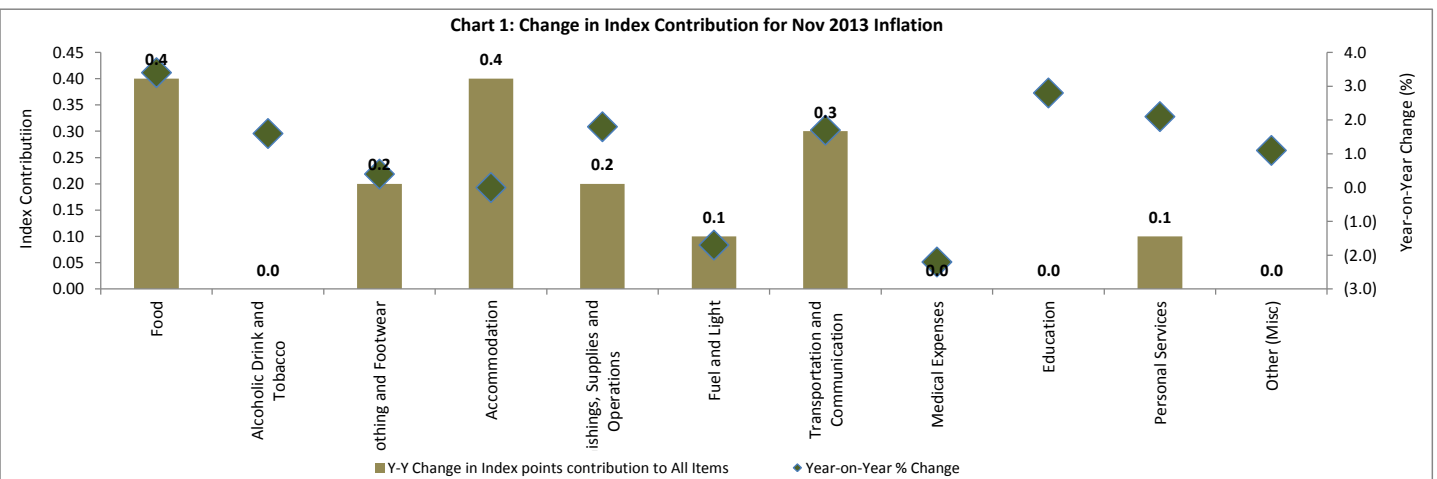

What is the Consumer Price Index?

The Consumer Price Index (CPI) is a statistical indicator of changes in the general level of prices of consumer goods and services purchased by private households. The CPI measures price movements of a fixed quality and quantity of goods and services. The mix of these consumer goods and services comprising the CPI are referred to as a "shopping basket." In constructing this "shopping basket", the selected goods and services are organised first by commodity type. They are then divided into sections, then sub-groups and then assigned to a major expenditure category. The Antigua and Barbuda CPI has 26 sections, 30 sub-groups and 11 major categories.

What is the Base Period?

The base period (base year) is the time period that is used as a reference point for measuring the price change of goods and services. The base period for the Antigua and Barbuda CPI is January 2001.

The base period index is represented as 100.0. (Usually presented as 2001 = 100). So for instance, if the April 2010 CPI for chicken legs is 167.1, then it means that the price for chicken legs has gone up by 67.1% since 2001. Similarly, if the January 2010 CPI for bread is 93.1, then the price of bread has dropped by 6.9% compared to its price in 2001.

What is Inflation?

Inflation is the process of rising prices, resulting in diminishing purchasing power of a given amount of money. There are three expressions of price changes:

- year-on-year (*the inflation rate*)
- month-to-month
- annual average (or annualised average)

The annual average CPI is derived by summing the CPI for each month of the year and dividing by 12.

What are Weights?

Weights can be considered in the same way we would express how much we spend on various goods and services each month. Just like a monthly salary can be broken down as 20% on rent, 25% food, 15% mortgage, 10% on utilities and so on, the CPI weights are a collective expression of how households would generally spend their monthly income on goods and services.

The weights for this series of CPI were drawn from a survey of a sample of households in 2001 (the base period). Each household was asked to keep a record of their expenditure for one month. Once completed, the expenditures were added to determine the pattern. This pattern is what is referred to as the weights.

The current weights assume that each month, households would spend the most on *Accommodation* (218.3) followed by *Food* (214.2) and *Transportation and Communication* (153.5). Households would also spend the least on *Alcoholic Drink and Tobacco* (1.6).

Index Points Contribution

Contribution of each expenditure category (category weight over All Items weight) to the All Items index points change.

The Statistics Division wishes to acknowledge the cooperation of the business community in supplying the required prices and accommodating the Statistical Officers on their premises. Price collection is authorised by the *General Statistics Act, No. 13 of 1975*.

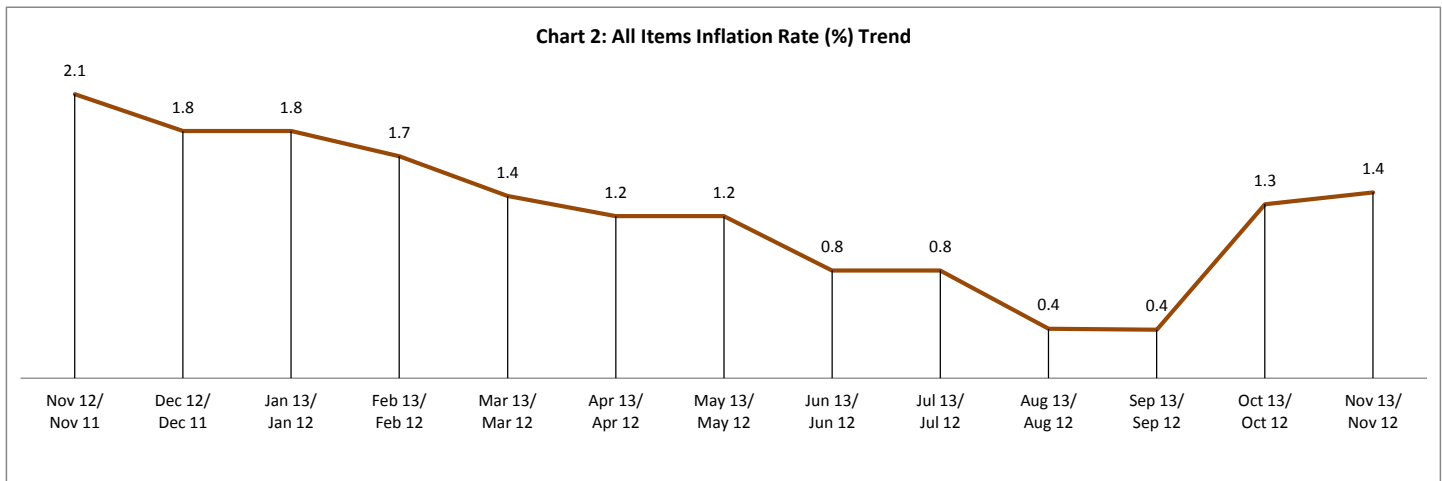

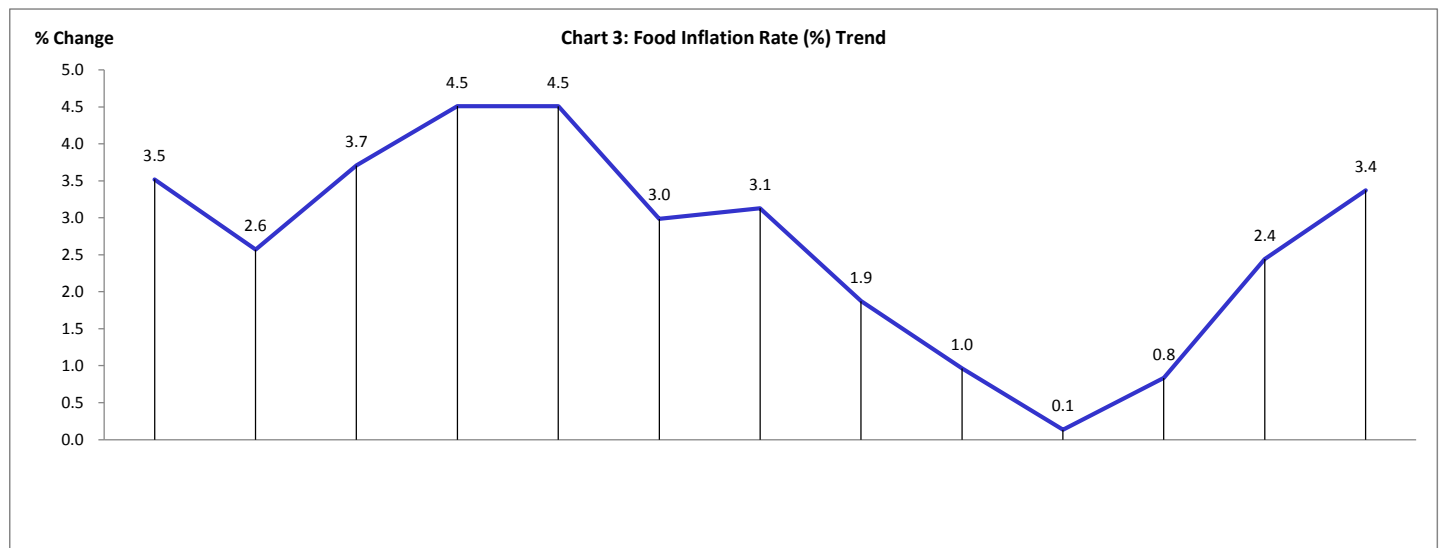

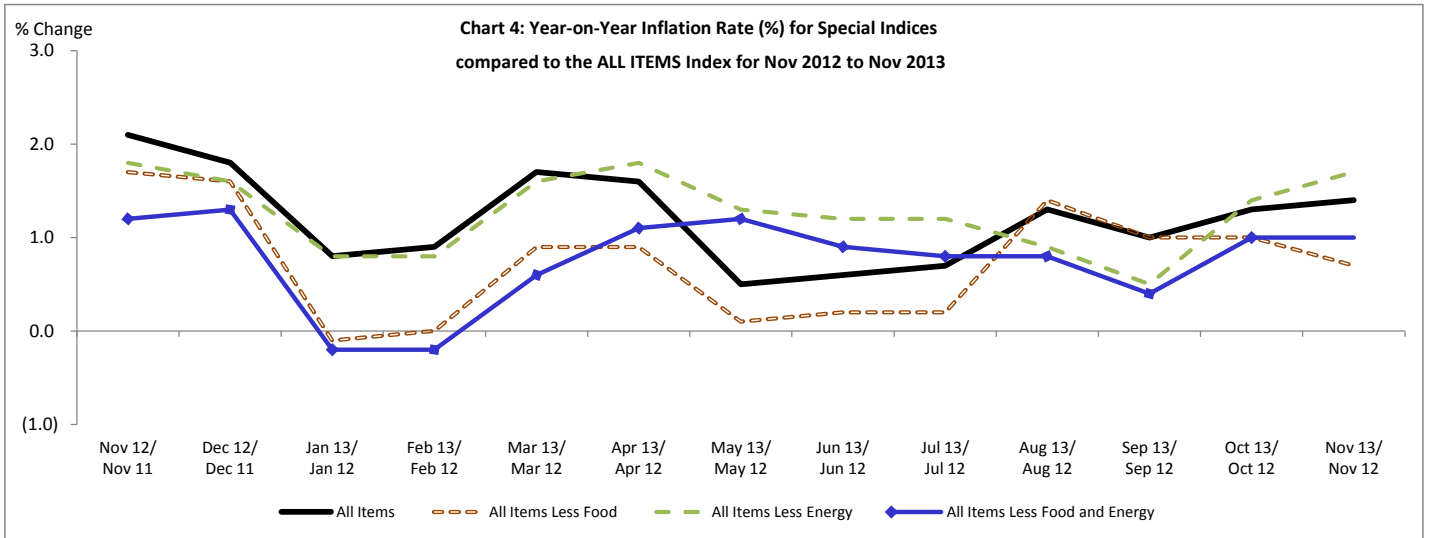
In Nov 2013 compared to Nov 2012, 2 of the 11 main expenditure categories recorded price decreases, while 8 recorded price increases. 20 of the 26 sub-group levels also recorded price increases for some of the items that fall in that level. These collective increases and decreases would account for the magnitude and direction of the current inflation rate. 1 of the 11 main expenditure categories recorded no price changes.
