



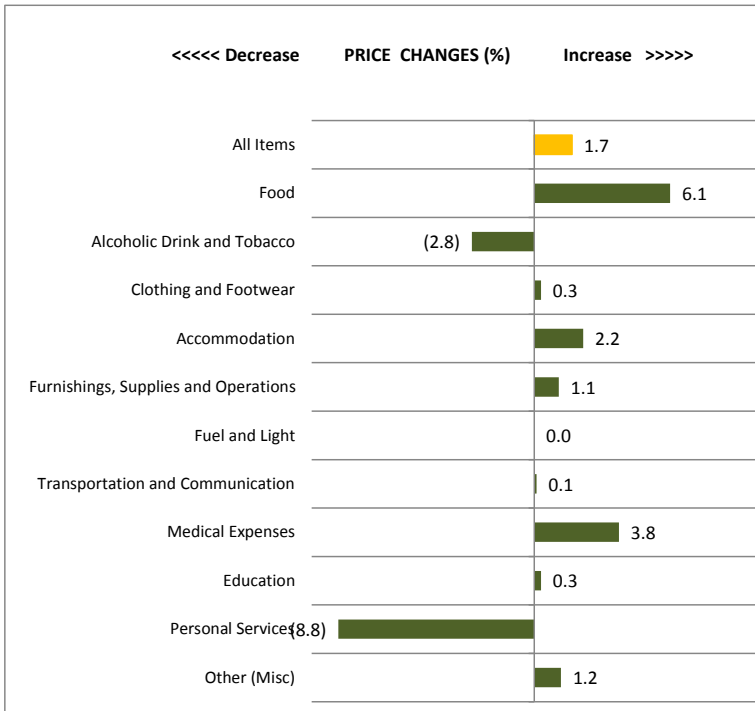
Antigua and Barbuda CONSUMER PRICE INDEX

Aug 2018 Inflation Rate 1.7%

Headline Inflation: Year-on-Year Changes for Aug 2018 compared to Aug 2017



The All Items Index rose 1.7% for the twelve months ending August 2018. The Index for Food increased 6.1% over the last 12 months. The major grocery store food groups indexes posted increases in August. The Index for Meats rose 13.6% with the Indexes for Poultry and Fish primarily contributing to the increases.

Fruits and Vegetables Index rose 5.8% as the Index for Fruit Juice advanced 27.8%.

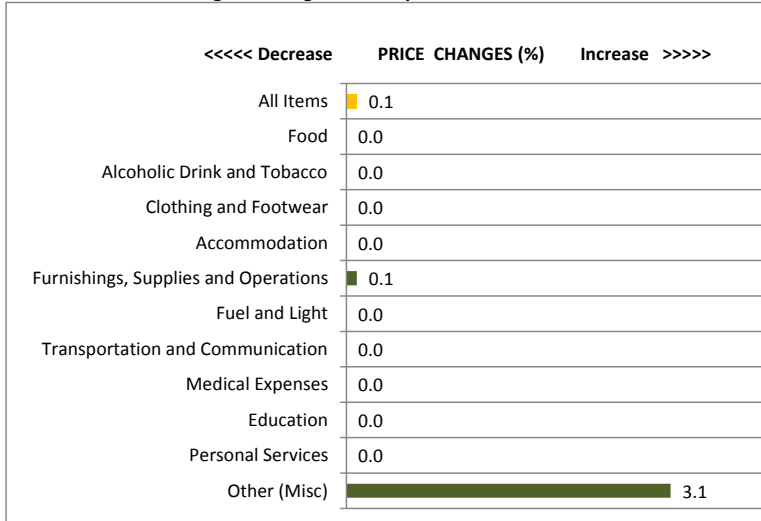
The Index for Bakery and Cereal Products rose 2.4% over the 12 months span. The other remaining major grocery store food groups indexes had similar increases except for Dairy Products which decreased by 3.2%.

The Alcoholic Drink and Tobacco Index decreased 2.8% with the Index for Alcoholic Beverages falling 3.3%. The Index for Personal Services declined 8.8% due to average price reduction in Laundry and Dry cleaning Services.

The Energy Index remains unchanged.

The Index for All Items Less Food and Energy was unchanged at 0.3%.

Month-to-Month Changes for Aug 2018 compared to Jul 2018



The Monthly Consumer Price Index increased 0.1% in August. The Food Index was unchanged. The major food groups indexes had mixed results in August. The Index for Meats rose 1.4% the largest increase in the food group category. Four other categories posted small increases.

Within the same food category the indexes for Bakery and Cereal, Fruits and Vegetables and Sugars, Jams and Confectionery all posted declines.

The Index for All Items Less Food and Energy increased 0.1% in August. The Index for Other (Miscellaneous) increased 3.1% and the Index for Furnishing, Supplies and Operations had a small increase of 0.1%.

The Energy Index remains unchanged.

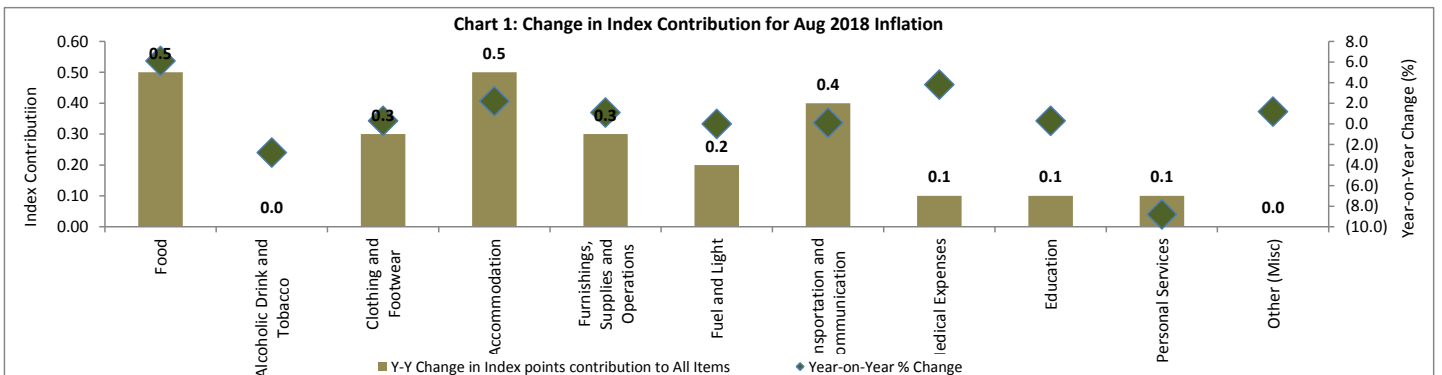

What is the Consumer Price Index?

The Consumer Price Index (CPI) is a statistical indicator of changes in the general level of prices of consumer goods and services purchased by private households. The CPI measures price movements of a fixed quality and quantity of goods and services. The mix of these consumer goods and services comprising the CPI are referred to as a "shopping basket." In constructing this "shopping basket", the selected goods and services are organised first by commodity type. They are then divided into sections, then sub-groups and then assigned to a major expenditure category. The Antigua and Barbuda CPI has 26 sections, 30 sub-groups and 11 major categories.

What is the Base Period?

The base period (base year) is the time period that is used as a reference point for measuring the price change of goods and services. The base period for the Antigua and Barbuda CPI is January 2001.

The base period index is represented as 100.0. (Usually presented as 2001 = 100). So for instance, if the April 2010 CPI for chicken legs is 167.1, then it means that the price for chicken legs has gone up by 67.1% since 2001. Similarly, if the January 2010 CPI for bread is 93.1, then the price of bread has dropped by 6.9% compared to its price in 2001.

What is Inflation?

Inflation is the process of rising prices, resulting in diminishing purchasing power of a given amount of money. There are three expressions of price changes:

- year-on-year (*the inflation rate*)
- month-to-month
- annual average (or annualised average)

The annual average CPI is derived by summing the CPI for each month of the year and dividing by 12.

What are Weights?

Weights can be considered in the same way we would express how much we spend on various goods and services each month. Just like a monthly salary can be broken down as 20% on rent, 25% food, 15% mortgage, 10% on utilities and so on, the CPI weights are a collective expression of how households would generally spend their monthly income on goods and services.

The weights for this series of CPI were drawn from a survey of a sample of households in 2001 (the base period). Each household was asked to keep a record of their expenditure for one month. Once completed, the expenditures were added to determine the pattern. This pattern is what is referred to as the weights.

The current weights assume that each month, households would spend the most on *Accommodation* (218.3) followed by *Food* (214.2) and *Transportation and Communication* (153.5). Households would also spend the least on *Alcoholic Drink and Tobacco* (1.6).

Index Points Contribution

Contribution of each expenditure category (category weight over All Items weight) to the All Items index points change.

The Statistics Division wishes to acknowledge the cooperation of the business community in supplying the required prices and accommodating the Statistical Officers on their premises. Price collection is authorised by the *General Statistics Act, No. 13 of 1975*.

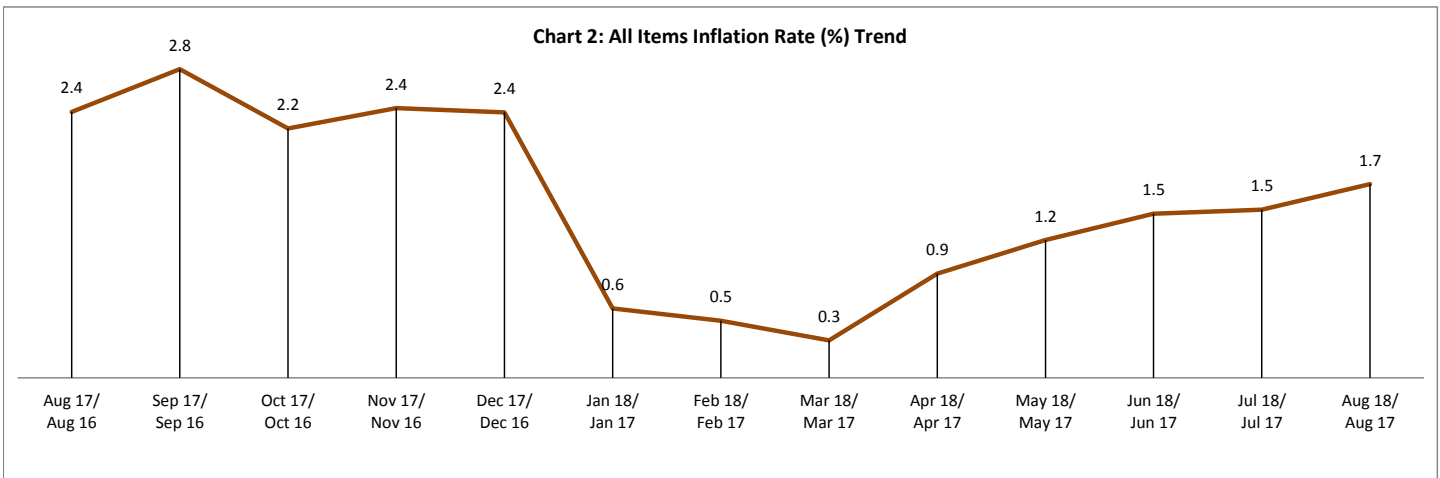

Table 3 outlines the distribution of price movements for four inflation periods:

Aug 2018 compared to Aug 2017
 Jul 2018 compared to Jul 2017
 Jun 2018 compared to Jun 2017
 Aug 2018 compared to Jul 2018

In Aug 2018 compared to Aug 2017, 2 of the 11 main expenditure categories recorded price decreases, while 8 recorded price increases. 17 of the 26 sub-group levels also recorded price increases for some of the items that fall in that level. These collective increases and decreases would account for the magnitude and direction of the current inflation rate. 1 of the 11 main expenditure categories recorded no price changes.
