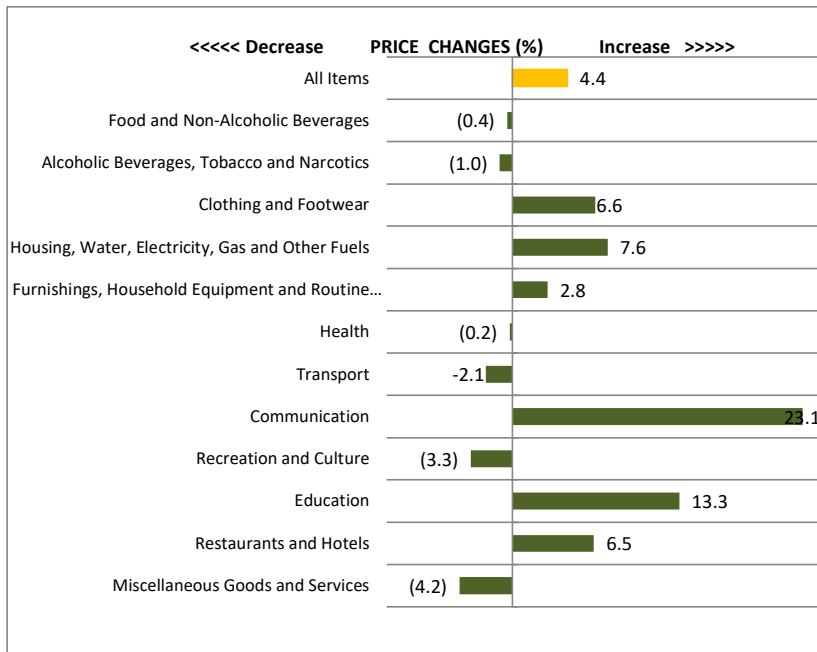

Headline Inflation: Year-on-Year Changes for Jul 2026 compared to Jul 2025



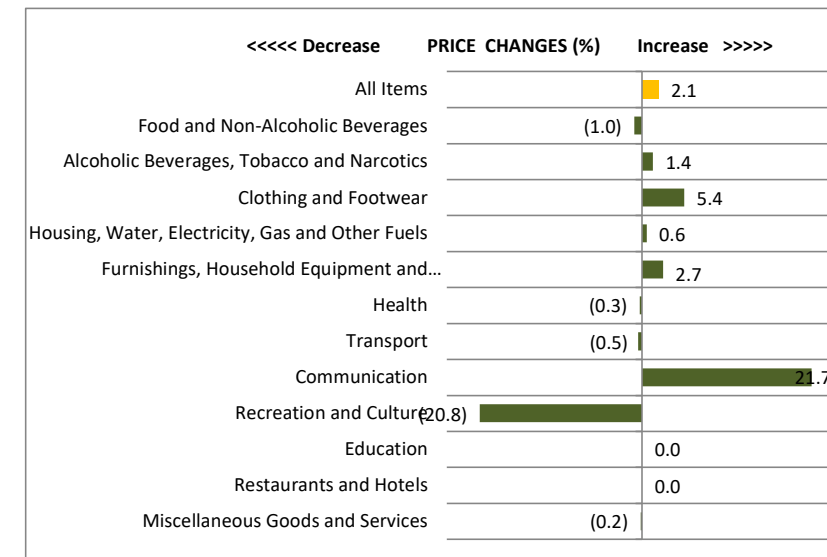
The Consumer Price Index (CPI) rose 4.4%, reflecting a broader increase in the cost of living. The All Items Less Food and Energy index rose from 128.77 to 133.99, an increase of about 4.1%. The Energy index increased 20.6% for the twelve months ending July 2026. Conversely, The Food and Non-Alcoholic Beverages index declined by 0.4% over the last year.

The Food index fell slightly (-0.8%) over the twelve months ending July 2026. The data indicates that food prices were generally declining overall, but movement was uneven across categories. Price decreases were recorded in some key products, particularly Fruit (-13.8%) and Meat and Meat Products (-5.0%), while Oil and Fats (+7.7%) and Food Products N.E.C. (+2.3%) saw notable increases.

The All-Items Less Food and Energy index increased by 4.1%. The index for Communication recorded the largest increase of 23.1%, making it the most significant upward movement. The index for Clothing and Footwear rose 6.6%, while Restaurants and Hotels index rose by 6.5%. The index for Furnishings and Household Equipment and Routine Household Maintenance increased moderately by 2.8%.

The index for Housing, Water, Electricity, Gas and Other Fuels increased by 7.6%. The Electricity index increased by 42.9%, and Actual Rentals for Housing rose by 2.0%, which is particularly important because housing and utilities are essential expenses. The Energy index increased 20.6% over the past twelve months.

Month-to-Month Changes for Jul 2026 compared to Jun 2026



The monthly Consumer Price Index increased 2.1% in July 2026. The Food and Non-Alcoholic Beverages Index declined 1.0% over the month of June 2026.

The Food index declined by 1.4% in July after a marginal increase of 0.1% in June. The Fish and Seafood decreased by 5.8% over the month. Within this group, Fresh Chilled or Frozen Fish and Seafood declined by 32.6%. The index for Fruit experienced a 4.0% decline, and Vegetable prices fell 2.1%. Conversely, the index for Milk, Cheese and Eggs increased by 4.7%, largely due to increases in Preserved and Other Milk Products. Other notable increases were Sugar, Jams, Honey, Chocolate, and Confectionery (+3.6%) and Meat and Meat Products (+1.3%).

The index for All Items Less Food and Energy rose 3.1% in July 2026. The index for Communication recorded the largest increase of 21.7%. The index for Clothing and Footwear also showed a significant contribution with an increase of 5.4%. Clothing Index alone increased 5.1%, while Footwear Index increased 6.5%. The index for Furnishings, Household Equipment and Routine Household Maintenance increased by 2.7%, with the indexes for Household textiles, Glassware, Tableware and Household Utensils contributing to this increase.

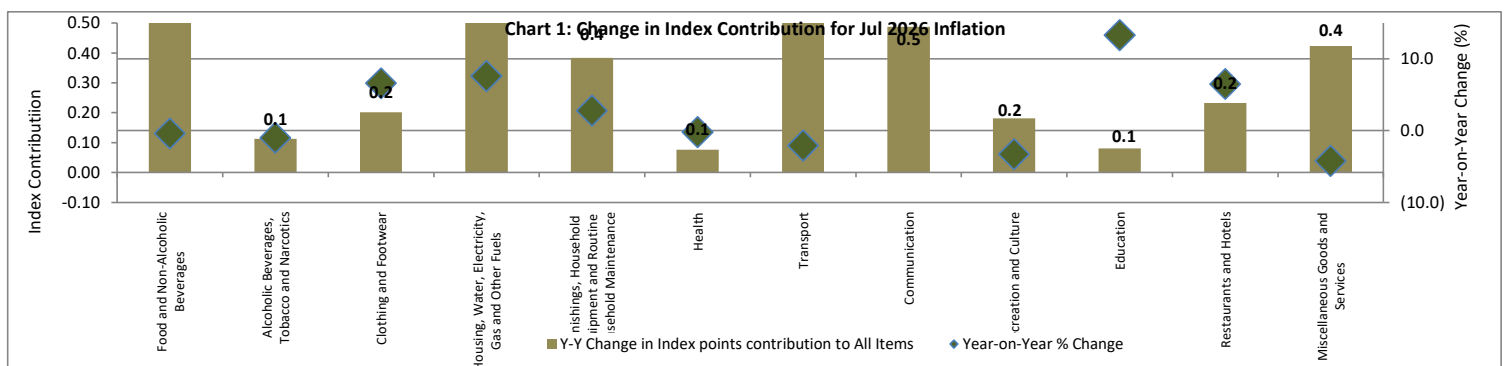

¹ Outlets refer to the businesses where prices are collected (e.g supermarkets). The same outlets are used for Food and Non-Alcoholic Beverages, Alcoholic Beverages, Tobacco & Narcotics and some Miscellaneous Goods and Services

What is the Consumer Price Index?

The Consumer Price Index (CPI) is a statistical indicator of changes in the general level of prices of consumer goods and services purchased by private households. The CPI measures price movements of a fixed quality and quantity of goods and services. The mix of these consumer goods and services comprising the CPI are referred to as a “shopping basket.” In constructing this “shopping basket”, the selected goods and services are organised first by commodity type. They are then divided into sections, then sub-groups and then assigned to a major expenditure category. The Antigua and Barbuda CPI has 26 sections, 30 sub-groups and 12 major categories.

What is the Base Period?

The base period (base year) is the time period that is used as a reference point for measuring the price change of goods and services. The base period for the Antigua and Barbuda CPI is January 2019.

The base period index is represented as 100.0. (Usually presented as 2019 = 100). So for instance, if the April 2020 CPI for chicken legs is 167.1, then it means that the price for chicken legs has gone up by 67.1% since 2019. Similarly, if the January 2020 CPI for bread is 93.1, then the price of bread has dropped by 6.9% compared to its price in 2019.

What is Inflation?

Inflation is the process of rising prices, resulting in diminishing purchasing power of a given amount of money. There are three expressions of price changes:

- year-on-year (*the inflation rate*)
- month-to-month
- annual average (or annualised average)

The annual average CPI is the arithmetic mean of the CPIs of the 12 months.

What are Weights?

Weights are "expenditure shares" that is the proportion of total spending on various consumer goods and services, for example, 20% on rent, 25% food, 15% transport, 10% on utilities and so on. the CPI weights are an expression of household's spending on consumer goods and services.

The weights were drawn from a survey of a sample of households in each month of 2006 (the weight base period). Each household in this sample kept a record of their expenditure for one month. Once completed, the expenditures were added to determine expenditure shares per 1000; these are the weights.

The current weights indicate that, households would spend the most on *Accommodation* (218.3 out of 1000) followed by *Food* (214.2) and *Transportation and Communication* (153.5). Households spend the least on *Alcoholic Drink and Tobacco* (1.6).

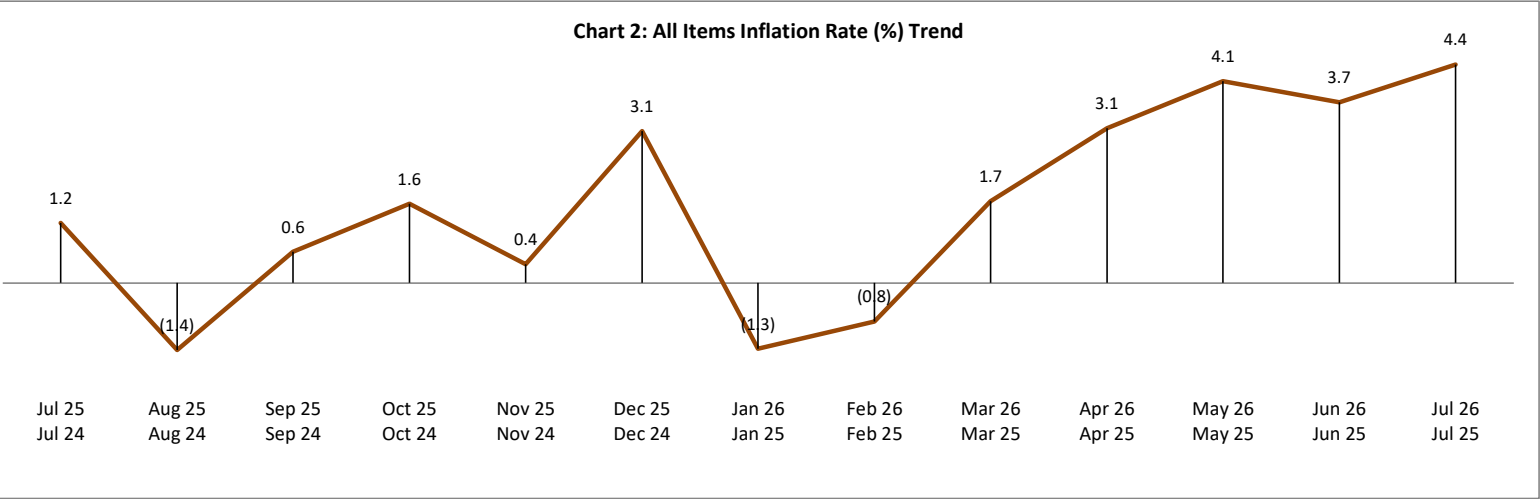

Table 3 outlines the distribution of price movements for four inflation periods:

Jul 2026 compared to Jul 2025
Jun 2026 compared to Jun 2025
Jul 2026 compared to Jun 2026

In Jul 2026 compared to Jul 2025, 6 of the 12 main expenditure categories recorded price decreases, while 6 recorded price increases. 11 of the 23 sub-group levels also recorded price increases for some of the items that fall in that level. These collective increases and decreases would account for the magnitude and direction of the current inflation rate. 0 of the 12 main expenditure categories recorded no price changes.
